The 2017-2021 Cement Masons Master Labor Agreement provides for a \$2.00 per hour increase effective July 1, 2018. The Union has determined to allocate the increase as follows: Vacation: \$0.05 increase, Administration Dues: \$0.04 increase, Defined Contribution Plan (IRA): \$0.21 increase, Defined Benefit Plan (Pension): \$0.20 increase, Health & Welfare: \$0.25 increase and to Wages: \$1.25 increase.

Effective July 1, 2018, the following wage rates are payable to Commercial Journeyman Cement Masons:
